The Erie Neighborhood Growth Partnership (ENGP) is the Erie Redevelopment Authorities Non-Profit arm. The estimated cost for a study and comprehensive plan is estimated at \$20,000. The ENGP has secured \$10,000 from the City of Erie/ECGRA and would like to request \$10,000 from the Erie County Land Bank. Aaron Snippert provided a one page informational sheet about land trusts.
